To consider the reopening of the library in response to the revision of the "Basic Response Policy for The New Coronavirus Infection Prevention Policy"

Although the extension of the emergency declaration based on the New Influenza Measures Act was decided, the "[Basic Policy for Measures against New Coronavirus Infection](#)", [revised](#) on May 31, and it says "museums, art museums, libraries, etc., in order to maintain a healthy life for residents, it is conceivable to open the premise that measures to prevent infection, such as the lack of infection, such as the lack of infection in the public population. It was said.

On the IFLA website, guidelines for the reopening of libraries are open to the public, which will be helpful when local governments develop action plans for the reopening of libraries in the future.
